Factor exposures

Norges Bank Investment Management measures the fund's exposure to various systematic risk factors such as small companies, value stocks and bonds with credit premiums. Risk factors capture common variations in returns of securities with similar characteristics, and contribute to both the risk and the return of the investments. Exposure to these factors can be estimated using the comovement of the fund's historical relative return with the historical returns of the factors.




Chart 1. Factor exposures of the fund's equity management relative to benchmark. Coefficients

An analysis of factor exposures for equity management indicates, among others, that the fund had greater covariance with small companies than the benchmark index at the end of the quarter. Around 20 percent of the variation in the relative return from equity management could be explained by general market movements and exposure to value stocks, small companies and emerging markets at the end of the first half of 2020.




Chart 2. Factor exposures of the fund's fixed-income management relative to benchmark. Coefficients

An analysis of the fund's fixed-income management indicates that the fund had limited covariance with movements in term and credit premiums at the end of the first half of the year. The model's explanatory power was around 2 percent at the end of the first half of 2020.

The results of such statistical regressions are uncertain. Norges Bank Investment Management uses a variety of supplementary approaches to analyse the fund's factor exposures.
